ORDINANCE NO. 10-2016

AN ORDINANCE AMENDING SECTION 13-128, LICENSE FEE; PENALTY; HALF-YEAR LICENSE; TERM, AND SECTION 13-131, HALF-YEAR LICENSES, OF CHAPTER 13, MOTOR VEHICLES AND TRAFFIC, OF THE EVERGREEN PARK MUNICIPAL CODE BY CHANGING VEHICLE LICENSE PROVISIONS FOR BUSES AND SCHOOL BUSES

BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Evergreen Park, Cook County, Illinois, as follows:

Section 1

That Section 13-128, License fee; penalty; half-year license; term, of Chapter 13, Motor Vehicles and Traffic, of the Evergreen Park Municipal Code, be amended to read as follows:

Sec. 13-128. License fee; penalty; half-year license; term.

(a) Annual fees. The license fee for each motor vehicle to be paid annually to the village clerk shall be as follows:

(1)	Passenger cars	\$ 35.00
(2)	Motorcycles, motor driven cycle, motorized pedalcycle	30.00
(3)	For-hire vehicles including taxicabs, limousines and liveries	100.00
(4)	All other first division vehicles	50.00
(5)	Authorized emergency vehicles	-0-
(6)	Bus (except owned by government or not-for-profit corporation)	100.00
(7)	Commuter van	35.00
(8)	Medical transport vehicle	50.00
(9)	Recreational vehicle	35.00
(10)	School bus (except owned by government or not-for-profit corporation)	100.00

Words and phrases shall have the meaning ascribed to them in the Illinois Vehicle Code.

Section 2

That Section 13-131, Half-year licenses, of Chapter 13, Motor Vehicles and Traffic, of the Evergreen Park Municipal Code, be amended to read as follows:

Sec. 13-131. Half-year licenses.

(16) Antique vehicles

If a vehicle has been purchased or lawfully acquired by the applicant on or after March 15 of any license year, the fee to be paid shall be a sum equal to one-half of the annual license fee hereinbefore specified as a license fee for the balance of such year. Before any applicant shall be entitled to a prorate-md license as provided for in this section, the applicant shall furnish an affidavit, in form satisfactory to the village clerk, stating that the vehicle for which the license is applied was purchased or otherwise obtained by the applicant on or after March 15 of the license year, and shall exhibit to the village clerk the bill of sale covering the vehicle for which the license is sought.

Section 3

The penalty clause of this ordinance shall be Section 1-9 of the Evergreen Park Municipal Code.

Section 4

If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

Section 5

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed insofar as they conflict herewith.

Section 6

This ordinance shall be in full force and effect after passage, approval, and publication for all vehicle licenses issued for the September 15, 2016 license year and thereafter. This ordinance is authorized to be published in pamphlet form.
