WAIVER OF CLAIMS, RELEASE AND HOLD HARMLESS AGREEMENT

Please read this form carefully and know that in signing this agreement you will be waiving and releasing any and all claims for injuries your child might sustain while participating in the program described below, and you will also be agreeing to reimburse The Village of Evergreen Park for any claims that may incur as a result of your child injuring anyone else in the course of your child's participation in this program.

DODGEBALL

As a participant in the Evergreen Park Youth Department dodge ball tournament, risks may include, but not limited to, all injuries associated with dodge ball, such as injuries associated with physical activity with other participants, exposure to athletic and game room equipment, exposure to video games, radio, all risks involved or associated with a public building, its ground and /or public washroom facilities within the building.

I agree to waive and relinquish all claims I may have as a result of my child's participation in the program against The Village of Evergreen Park, and its officers, agents and employees.

I agree to hold harmless and indemnify VILLAGE OF EVERGREEN PARK, and its officers, agents, servants, and employees from any and all claims from injuries, damage or loss which my child, my spouse or I may have, or which may occur to us on account of my child's participation in the program.

I further agree to indemnify and hold harmless and defend VILLAGE OF EVERGREEN PARK and its officers, agents, servants and employees from any and all claims resulting from injuries, damages and losses caused by my child or during the course of my participating in the activities of the program.

In the event of an emergency, I authorize VILLAGE OF EVERGREEN PARK officials to secure from any licensed hospital, physician, and/or medical personnel any treatment deemed necessary for my child's immediate care and I agree that I will be responsible for payment of any and all medical services. I have read and fully understand the above Program Details, Waiver and Release of all Claims, Hold Harmless Agreement and Permission to Secure Treatment.

I hereby release the Evergreen Park Youth Department, The Village of Evergreen Park and its employees from any claims, which might arise from injuries, incidents, and accidents beyond their control.
