ORDINANCE NO. 6-2020

AN ORDINANCE OF THE VILLAGE OF EVERGREEN PARK AMENDING ARTICLE XIV, SIMPLIFIED TELECOMMUNICATIONS TAX, OF CHAPTER 11, LICENSES, TAXATION, BUSINESS REGULATIONS, OF THE EVERGREEN PARK MUNICIPAL CODE

BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Evergreen Park, Cook County, Illinois, as follows:

Section 1

That Article XIV, Simplified Telecommunications Tax, of Chapter 11, Licenses, Taxation and Miscellaneous Business Regulations of the Evergreen Park Municipal Code, be amended to read as follows:

Sec. 11-410. Tax Imposed. A simplified municipal telecommunications tax is hereby imposed upon the act or privilege of originating in the Village or receiving in the Village intrastate or interstate telecommunications by a person at the rate of 6.0% of the gross charges for such telecommunications purchased at retail from a retailer, in accordance with and subject to the provisions of the Simplified Municipal Telecommunications Tax Act (35 ILCS 636/5-1, *et seq.*).

Sec. 11-411. Illinois Department of Revenue to Administer. The tax hereby imposed shall be collected and enforced by the Department of Revenue of the State of Illinois. The Illinois Department of Revenue shall have full power to administer and enforce the provisions of this Article.

Section 2

The Village Clerk is hereby directed to file a certified copy of this ordinance with the Illinois Department of Revenue prior to September 20, 2020.


Section 3

This ordinance shall be in full force and effect after from and after its passage, approval, and publication in pamphlet form as required by law, provided, however, that Section 1 of this ordinance shall take effect for all gross charges billed by telecommunications retailers on the first day of January next following the passage and filing of this ordinance with the Department of Revenue, if filed on or before the preceding September 20th.

Section 4




