ORDINANCE NO. 31-2013

AN ORDINANCE AMENDING SECTION 3-56, LICENSE CLASSIFICATIONS, OF CHAPTER 3, ALCOHOLIC LIQUOR, OF THE EVERGREEN PARK MUNICIPAL CODE PERTAINING TO PERMITTED OPERATIONS OF CLASS C LICENSEES

BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Evergreen Park, Cook County, Illinois, as follows:

Section 1

That Section 3-56, License classifications, of Chapter 3, Alcoholic Liquor, of the Evergreen Park Municipal Code be amended to read as follows:

Sec. 3-56. License classifications.

Licenses for sale at retail of alcoholic liquor shall be divided in the following classes:

...

(3) *Class C, package sales.* A Class C license entitles the licensee to make sales at retail of packages alcoholic liquors for consumption off the premises and allows the licensee to serve tasting samples of alcoholic liquors without charge for consumption on the premises. A Class C licensee is also permitted to have wine tasting and alcoholic liquor tasting sessions for which it charges a fee, provided that the Local Liquor Control Commissioner approves the same.

Section 2

Unless otherwise provided, the penalty clause for this ordinance shall be Section 1-9 of the Evergreen Park Municipal Code.

Section 3

If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

Section 4

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed insofar as they conflict herewith.

Section 5

This ordinance shall be in full force and effect after passage, approval, and publication. This ordinance is authorized to be published in pamphlet form.
