ORDINANCE NO. 4-2015

AN ORDINANCE AMENDING SECTION 12-355, PLAYING GOLF ON PUBLIC PROPERTY PROHIBITED, OF CHAPTER 12, MISCELLANEOUS PROVISIONS AND OFFENSES, OF THE EVERGREEN PARK MUNICIPAL CODE

BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Evergreen Park, Cook County, Illinois, as follows:

Section 1

That Section 12-355, Playing golf on public property prohibited, of Chapter 4, Miscellaneous Provisions and Offenses, of the Municipal Code of Evergreen Park be amended to read as follows:

Sec. 12-355. Playing golf prohibited.

(a) It shall be unlawful for any person at any time to play or practice golf upon any public park, public right-of-way, or public property within the Village except that golf shall be permitted from designated tee areas at the driving range owned by the Village and Frisbee golf shall be permitted at the Frisbee golf course owned by the Village.

(b) It shall be unlawful for any person to use the Village of Evergreen Park driving range without paying the required fee therefor.

(c) It shall be unlawful for any person to use the Village of Evergreen Park driving range for any purpose other than hitting practice balls from designated tee areas.

Section 2

The penalty clause for this ordinance shall be Section 1-9 of the Municipal Code of Evergreen Park.

Section 3

If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

Section 4

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed insofar as they conflict herewith.

Section 5

All statutes of the State of Illinois or any parts thereof which are in conflict with the provisions of this ordinance are hereby superseded by this ordinance enacted under the home rule power of the Village of Evergreen Park.

Section 6


This ordinance shall be immediately in full force and effect after passage, approval, and publication. This ordinance is authorized to be published in pamphlet form.


