## REQUIREMENTS FOR VIDEO GAMING LICENSE

### Village Requirements:

1. Village application completed
2. Copy of completed application to the Illinois Gaming Board
3. Copy of license issued from Illinois Gaming Board
4. Fees (according to the Village application)

### Building Department Requirements:

1. Permit submitted for the build-out for a gaming room
2. A site plan showing the location of the gaming room within the establishment must be submitted also the type and construction barrier to be utilized to separate the gaming room. If the proposed separation is to be of permanent construction then this site plan must be submitted as stamped architectural drawings.
3. Written scope of work
4. All contractors listed on permit must be licensed to work in the Village
5. Final inspections completed and approved for permit work

Any fees/money owed to the Village (business license, liquor license fees, etc.) must be paid and business must be in good standing with the Village.

Name on the liquor license, gaming application (ours & State of Illinois) must match.
