ORDINANCE NO. 8-2021

AN ORDINANCE AMENDING CHAPTER 11, LICENSES, TAXATION AND MISCELLANEOUS BUSINESS REGULATIONS, BY CHANGING SECTION 11-608, ADVERTISING, OF THE EVERGREEN PARK MUNICIPAL CODE

BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Evergreen Park, Cook County, Illinois, as follows:

Section 1

That Chapter 11, Licenses, Taxation and Miscellaneous Business Regulations, of the Evergreen Park Municipal Code, be amended by changing Section 11-608, Advertising, to read as follows:

Sec. 11-608. Advertising.

(a) It shall be unlawful to advertise or promote video gaming on any private property or public property (including a street, alley, right-of-way, park or public place) which can be seen from any street, alley, or sidewalk. No banners, signs or flags shall be placed on public or private property to advertise or promote any video gaming.

(b) It shall be unlawful for any person to use lighting (including strobe lights, racing lights, and LED lights) visible from the exterior of any building where video gaming is licensed to be conducted to advertise or promote any video gaming.

(c) It shall be unlawful for any person to use any amplified sound (including speakers, live music and recorded music or speech) audible from the exterior of any building where video gaming is licensed to be conducted to advertise or promote any video gaming.

Section 2

This ordinance was passed pursuant to the home rule powers of the Village of Evergreen Park.

Section 3

If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

Section 4

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed insofar as they conflict herewith.


Section 5

All statutes of the State of Illinois or any parts thereof which are in conflict with the provisions of this ordinance are hereby superseded by this ordinance enacted under the home rule power of the Village of Evergreen Park, except for the provisions Sec. 3-5 of the Evergreen Park Municipal Code.

Section 6

This ordinance shall be immediately in full force and effect after passage, approval and publication. This ordinance is authorized to be published in pamphlet form.


