ORDINANCE NO. 22-2021

AN ORDINANCE LEVYING TAXES FOR GENERAL CORPORATE PURPOSES FOR THE TAX YEAR 2021 FOR THE VILLAGE OF EVERGREEN PARK, COOK COUNTY, ILLINOIS

BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Evergreen Park, Cook County, Illinois:

Section 1

That the amount of \$7,007,201 is hereby levied upon all taxable property within the corporate limits of the Village of Evergreen Park, Cook County, Illinois, for the tax year 2021, for the following purposes, which sums are set forth under the column entitled "Levy":

Section 2

That the County Clerk is hereby directed to add to the amount levied above a sum equal to 0% of said amount to cover loss in collecting the tax.

Section 3

If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

Section 4

All statutes of the State of Illinois or any parts thereof which are in conflict with the provisions of this ordinance are hereby superseded by this ordinance enacted under the home rule power of the Village of Evergreen Park.

Section 5

This ordinance shall be immediately in full force and effect after passage and approval.
